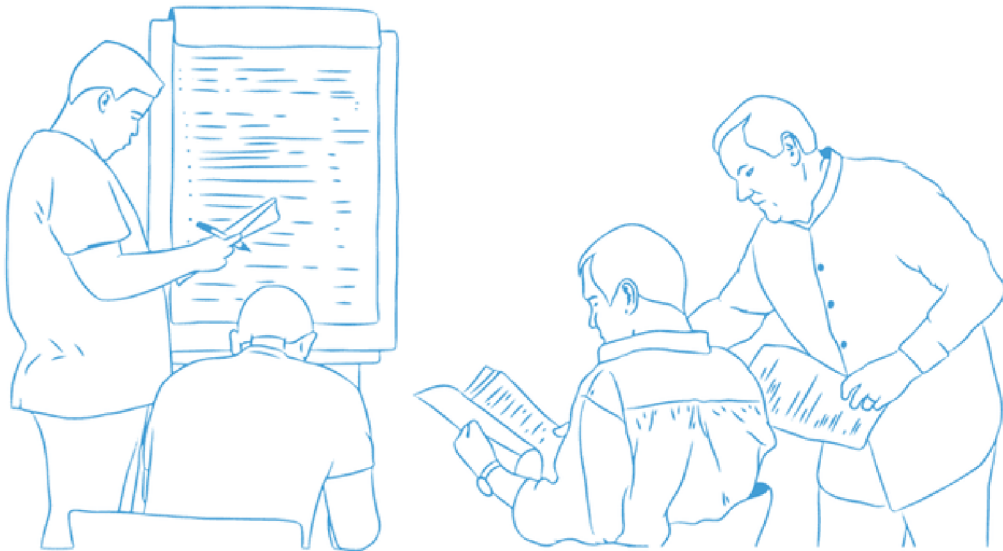

## Are you still officially certified to audit against the ISO 14001:2004 Standard?



Environmental Auditors who trained to the 2004 issue of ISO 14001, had a grace period of three years to update their qualification (as required by the replacement Standard, ISO 14001:2015). However this had to be completed by [2018](#).

Since no organisation is registered against the obsolete ISO 14001:2004, nowadays, it means auditors who haven't stayed up-to-date risk their audits being rejected during their employer's Certification audits.

The [good news](#) is, it's still possible to rejuvenate your defunct Auditor certificate, thanks to our personal tuition service; as well as for groups of 3 or more, in-house or online.

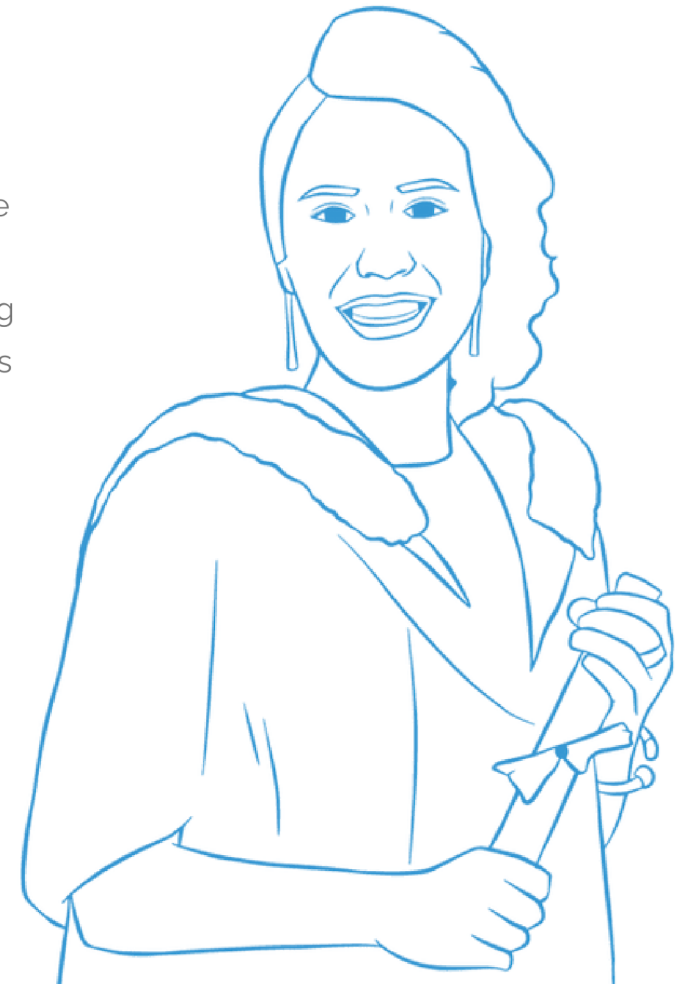
## Should I update or completely re-train?

ISO 14001:2015 has completely taken over from the old ISO 14001:2004, but auditors previously trained to the older version **do not** have to re-take an entire Internal or Lead Auditor course to stay 'valid' - you can update your qualification through this single-day, SQMC module.

Our ISO 14001 Transition training will be beneficial for anyone maintaining an Environmental Management System (EMS). Managers affected by an EMS should also consider attending the course, to gain a clear understanding of how the changes and additional clauses will impact their role.

Freelance consultants and trainers will also want to attend, and the course is worth 7 Continuing Professional Development (CPD) points in the Chartered Quality Institute.

**Please note**, however, that auditors who are personally registered with IRCA may require to undertake a two-day course, not offered by SQMC, to maintain their registered status.



## What will I learn?

This ISO 14001 Transition course focuses predominantly on the 'nuts and bolts' of the latest QMS Standard. The most notable issues we'll cover during your tuition are:

- The major additional clause governing the Management of Risk.
- The other major additional clause focusing on the Context of an Organisation.
- An explanation of "Annex SL" - the inspired framework on which all Management Systems Standards are being built.

Participants will receive a complimentary copy of ISO 14001 (which has a non-member value of £142, if purchased from the British Standards Institute), and those who successfully complete SQMC's continuous assessment exercises throughout the module will be awarded a globally-recognised Certificate of Achievement.

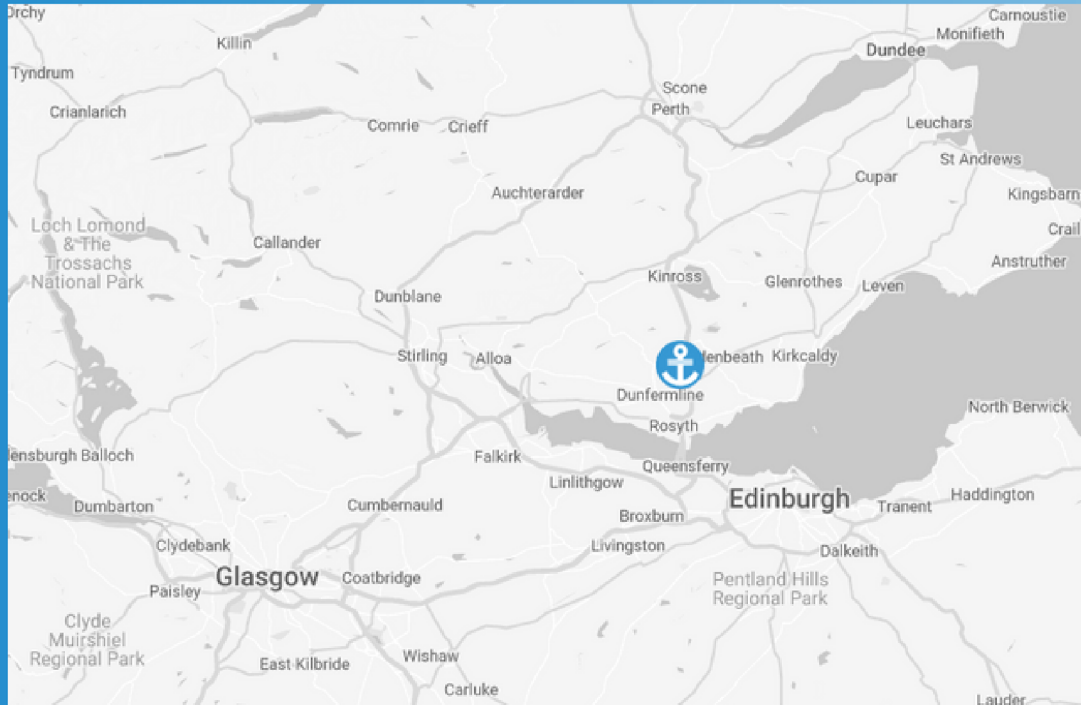
